E = Title 62.1-44.19:14.G. of the [Code of Virginia](#) (2021 Acts of Assembly, Chapter 363)

- (1) James River Trading Restriction: In order to protect upstream water quality, facilities in the upper and middle James River shall not obtain wasteload allocations or compliance credits from lower James River facilities. This restriction shall not restrict lower James River facilities from obtaining wasteload allocations or compliance credits from upstream facilities.
- (2) For new facilities that have not previously discharged, the allocation is effective upon issuance of a Certificate to Operate. For expanding facilities, the allocation is effective as of January 1 of the calendar year immediately following the year in which a Certificate to Operate (or equivalent industrial activity) was issued at the design flow listed above.
- (3) Wasteload allocations for localities served by combined sewers are based on dry weather design flow capacity. Reported discharge loads for the Lynchburg STP shall include the loads associated with the first 22 MGD of flow on each day. Reported discharge loads for the Richmond WWTP shall include the loads associated with the first 45 MGD of flow on each day.
- (4) Oilville WWTP (VAN040145) Total Nitrogen wasteload allocation of 2,750 lbs/year (delivered) and Total Phosphorus wasteload allocation of 275 lbs/year (delivered) for calendar years 2013 through 2022 provided by the City of Richmond (VAN040085) under the Nutrient Allocation Addendum to the Wastewater Agreement between The County of Goochland, Virginia and The City of Richmond, Virginia dated August 4, 2009. The agreement is for an initial term of ten (10) years, from January 1, 2011, and extends for the term of any future VAN General Permit reissuance if sought by Goochland County and as long as VAN040085 remains in effect with a discharged total nitrogen wasteload allocation of 1,096,402 lbs/yr and a discharged total phosphorus wasteload allocation of 68,525 lbs/yr. Upon termination of the wastewater agreement, these allocations revert back to the City of Richmond.
- (5) Wasteload allocations are “net” loads, based on the portion of the nutrient discharge introduced by the facility’s process waste streams, and not originating in raw water intake.
- (6) The Hampton Roads Sanitation District’s James River Aggregate TN WLA is binding upon HRSD’s regional system as a whole; it is neither derived nor limiting upon individual facilities (or their associated design flows and specific removal efficiencies) comprising the regional system.
- (7) CBBT-Parallel Thimble Shoal Tunnel Project Total Nitrogen wasteload allocation of 100 lbs/year (delivered) and Total Phosphorus wasteload allocation of 550 lbs/year (delivered) for calendar years 2022 through 2026 provided by Hampton Roads Sanitation District in an amended Nutrient Offset Agreement dated September 28, 2021. Upon termination of the wastewater agreement, these allocations revert back to Hampton Roads Sanitation District.
- (8) Beginning 2020, the Hampton Roads Sanitation District permanently retired 100 lbs/yr TN and 10 lbs/yr TP (at a ratio of 10 lbs/yr TN for every pound of TP) to offset new land disturbance activities by a publicly-owned treatment works as an alternative to acquiring perpetual nutrient credits, in accordance with Code of Virginia §62.1-44.19:21.2.C.
- (9) Hampton Roads Sanitation District permanently acquired an additional wasteload allocation of 153,500 lbs/yr of Total Nitrogen and 21,500 lbs/yr of Total Phosphorus from J.H. Miles & Co. under a Wastewater Treatment and Nutrient Allocation Consolidation Agreement dated December 21, 2015. The allocation was subsequently subject to a 9VAC 25-820-80 Phase 2 Total Phosphorus reduction to 17,437 lbs/yr effective January 1, 2017, then codified into statute at Title 62.1-44.19:14.G of the Code of Virginia (2021 Acts of Assembly, Chapter 363).
- (10) Hampton Roads Connector Partners, Hampton Roads Bridge Tunnel I-64 Expansion (VAN040176) delivered allocations reflect a temporary transfer of 4,000 lbs/year Total Nitrogen and 2,000 lbs/year Total Phosphorus from the Hampton Roads Sanitation District’s aggregate allocations (VAN040090) for compliance years 2020 through 2025 in accordance with a Nutrient Offset Agreement dated October 29, 2020. Upon termination of the agreement, the allocations revert back to HRSD.
- (11) G. Robert House, Jr. WTP Total Phosphorus wasteload allocation of 12,739 lbs/yr based on a permitted design capacity of 3,728 lbs/yr plus 9,011 lbs/yr of Total Phosphorus allocation provided by HRSD for calendar years 2015 through 2053
